Reviewer 1

This study intends to investigate the morphophonemics and productivity of the morphemes N- + and their underlying principles. The study's abstract is incomplete as it does not provide a proper introduction and purpose. Moreover, the study's abstract does not present a brief overview of the findings.

The study's introduction includes the history of the language and a note on morphology while it has ignored the Morphophonemic of the Morpheme. The study should consist of it in the introduction. The literature review is very limited as it includes only two areas, and very limited studies are referred to in this part of the paper. It must be enhanced, and a detailed review of previous research must be included.

The author claims to triangulate through method, theory and research in the methodology part. It is not a triangulation of data. Triangulation of data refers to using multiple methods or sources to confirm the validity and reliability of research findings. This involves cross-checking data obtained from different sources or methods to verify the accuracy and consistency of the results. The researcher should define clearly how triangulation has been done.

The results have been properly entered, tabulated, and discussed in detail. However, the conclusion is not complete. It does not summarize all findings and does not address the topic. The conclusion must be enhanced, and it must be written again.

The language used in the paper is very poor and not up to the mark. There are sentences which are unclear, ambiguous and complex. They should be made clear and simple. There are grammatical errors in punctuation, pronouns, capitalization, spacing tenses, article and like. These errors must be removed before submitting the final copy of the article. Moreover, the paper is not formatted as per the style of the journal. It must be reformatted.

All in all, the research is good and can be published. The topic is new and will find a readership. It will be a good addition to the body of knowledge, but the paper cannot be published with said revisions.

This study aims to investigate the morphophonemic and productivity of the morphemes N- and +, as well as the underlying principles that govern these properties. The abstract does not cover the study's goal and its proper introduction, so it cannot be considered complete. In addition, the study's abstract does not provide a synopsis of the findings in any way, shape, or form.

The history of the language and a remark on morphology are covered in the introduction to the study. Nevertheless, the morphophonemic analysis of the morpheme is not covered at all. That ought to be discussed in the study's introductory section. The literature review is extremely limited because it only covers two different subject areas and only refers to a small number of different research overall in this section of the work. That has to be improved, and you need to provide a comprehensive evaluation of the studies done in the past.

In the section devoted to the methodology, the author asserts that the use of technique, theory, and research achieved triangulation. This is not an example of data triangulation. The term "triangulation of data" refers to confirming the validity and dependability of research findings by drawing on various approaches or sources. This requires verifying the quality and consistency of the outcomes by cross-checking the data acquired from multiple sources or methods to complete the process. The researcher needs to provide a detailed explanation of how triangulation was performed.

The data have been recorded accurately, tallied, and discussed in great depth. The conclusion is not entirely accurate. It does not address the topic or summarise all the findings. In addition to being rewritten, the conclusion needs to have some improvements made to it.

The quality of the language used in the report is quite low and does not meet the requirements. Certain sentences are difficult to understand, unclear, and ambiguous. Things need to be made understandable and uncomplicated. Errors in punctuation, pronouns, capitalization, spacing, tenses, articles and similar elements can be found throughout the text. These errors must be rectified when submitting the final copy of the article. Moreover, the paper is not formatted as per the style of the journal. It must be reformatted.

Overall, the research is solid and worthy of publication in its current form. The subject is fresh, and it will attract the attention of readers. Yet, the manuscript cannot be published with the suggested amendments because it would be a valuable contribution to the existing body of knowledge.
